Supervisor Responsibilities:

- The supervisor must be at least 21 years old if the trip does not include an overnight stay on the Helsinki Tallinn route.
- The supervisor must be at least 25 years old if the trip includes an overnight stay. The exception is a supervisor under 25 who is a teacher or coach supervising their students.
- The supervisor must board the ship together with the minors under their supervision.
- The supervisor must inform the minors that they must follow Tallink Silja Line's rules of conduct on the ship.
- The supervisor must familiarize themselves with the ship's safety instructions and also ask the minors to do so.
- The supervisor must monitor the minors' behavior on the ship throughout the journey and immediately address any inappropriate behavior.
- The supervisor must contact the ship's security personnel if necessary, available through the information desk around the clock.
- The supervisor must act in all situations considering the interests of the minors under their supervision, other passengers, and the shipping company.
- The supervisor must ensure quietness in the cabins after 11:00 PM.
- The supervisor must ensure that no alcoholic beverages, drugs, or spray paints are brought onto the ship.
- The supervisor must ensure that minors do not consume alcohol or drugs.
- Providing alcohol to minors is a punishable act.
- Minors must be made aware that they are responsible for any damage caused and inappropriate behavior.
- Minors must be made aware that damaging the ship could lead to removal from the ship at the next port.
- The supervisor is liable for any damage caused by the minors under their supervision.
- The form must be submitted at the beginning of the trip to the ship's information desk.

I accept the requirements set for the supervisor, take responsibility for the minors, and agree to compensate for any damage caused by the minors under my supervision.
